The PRO members watched attentively as Mr. Saksen delivered a PowerPoint presentation with beautiful renderings,

photos and statistics of the new hospital. The room was filled with both excitement and questions.

The audience spoke with familiarity, making anecdotal references to the current Parkland hospital, while asking about provisions for the new facilities. Mr. Saksen answered questions on topics ranging from parking lot expansions to the new pneumatic tubing system. PRO President Jeanne Wainer seemed to capture a common sentiment when she exclaimed, "The new hospital sounds so wonderful! I almost wish I wasn't retired so, I could join in on the excitement!"



The PRO was founded in July 2003 by Katie Huber and Anna Robinson. The two organized an event at the Sheraton Hilton Hotel, inviting as many Parkland retirees as possible to join a mission to rekindle friendships and provide retirement enrichment opportunities in support of Parkland Health & Hospital System and the Parkland Foundation.

Fifty-two retirees attended that first meeting, held August 25, 2003. Over the past decade, the group has grown quite significantly and membership now logs at 139 retirees.

## New Parkland

The new Parkland hospital is a dynamic project and is often a subject of interest to the community.

The hospital is scheduled to be completed in 2014. The building will be ready for occupancy in the spring of 2015.

With a campus covering 2.5 million square feet, the project is the largest new hospital construction project in the country and is creating an estimated 3,000 new jobs during the course of the construction.

Once completed the campus will include:

- 862-bed acute care hospital (1.7 million square feet)
- Outpatient center (175,000 square feet) it will be completed in May 2015, after the hospital opens
- Parking for 6,000 vehicles
- Central Utility Plant
- WISH Clinic

With good stewardship in mind, we are building a first-class hospital while remaining fiscally prudent. In addition to debt, the building program is also funded by current and future reserves, as well as philanthropic support.

## Construction Financing Plan:

- 2009 Bond Package - \$702 million
- Future Bond Issue - \$42 million
- Current Cash Reserves - \$250 million
- Future Cash Reserves - \$142 million
- Investment income - \$40 million
- Philanthropy - \$150 million

The total project cost is \$1.27 billion.
